New members' biographies:



Mick McAteer is: Co-Director of the Financial Inclusion Centre; Chair of Registry Trust and anti-poverty charity Z2K; Deputy Chair of the Consumer Council of Northern Ireland; and Council Member of the Irish Financial Services and Pensions Ombudsman. He was previously on the boards of the Financial Services Authority and Financial Conduct Authority, chaired the European Commission's Financial Services User Group, and led Which?'s policy work on financial services.



Cloda Jenkins is a Professor (Teaching) in the Economics Department at University College London, Associate Director for the UCL Centre for Teaching and Learning Economics (CTaLE). She has worked as a regulatory economist since 1997, providing advice and training to European companies and regulators in the energy, post, transport, and water sectors. In addition to many advisory roles, she was Head of Ofgem's review of energy network regulation (RPI-X@20) between 2008 and 2010.



Professor Suzanne Rab is a barrister at Serle Court Chambers. Suzanne has two decades of wide experience of regulation, EU and competition law matters combining trade, cartel regulation, commercial practices, IP exploitation, merger control, public procurement, and subsidy control. Suzanne is a member of the board and senior research associate at the Regulatory Policy Institute. She is Professor of Commercial Law and holds the Practice Chair at Brunel University, London, a law lecturer at the University of Oxford and Visiting Professor at Imperial College (specialising in IP and antitrust). Suzanne is a non-executive board member and member of the audit and risk committee of the Legal Aid Agency.



Helen is Chief Executive of the Money and Mental Health Policy Institute, the research charity set up by Martin Lewis to better understand and tackle the link between financial difficulty and mental health problems. Since its inception in 2016 the charity has become a leading voice on issues from debt to impulsive spending, mental health services, consumer protection and the potential for big data and open banking for vulnerable customers. Helen was a core part of the founding team at Money and Mental Health, running the organisation's communications and influencing work before becoming CEO over two years ago.

Helen previously led Mind's policy and campaigns work on public mental health and social care as well as working for a number of different third sector organisations and in Parliament. Helen sits on the advisory group to the board of the Money and Pensions Service, the Government's Financial Inclusion Policy Forum, the UK Finance Consumer Advisory Group and the advisory board for suicide prevention charity Jonathan's Voice.
