Matthew will look at the way that barristers support lawyers in offshore jurisdictions, in particular his role in connection with the attempts to resuscitate the Black Swan injunctive jurisdiction in the BVI, which the Privy Council have breathed some life into by staying the Court of Appeal's order in *CCL v. Broad Idea*.

Dan will talk about the case of *Re Infund LLP* in which he is instructed to appear in the Supreme Court along with John Machell QC, also from Serle Court. The case concerns a claim by Infund LLP to shares in Grupo Mexico with an estimated value of US\$2.5 billion, which claim was held to be fraudulent at first instance. One of the issues that it raises is whether a foreign layperson who follows advice from reputable English solicitors as to technical matters of English law can properly be held to have acted dishonestly by so doing.

Charlotte is instructed in *Public Institution for Social Security of Kuwait v. Al Rajaan,* one of the Top 20 cases of 2020. She will discuss the operation of exclusive jurisdiction clauses in the context of fraud claims and whether the European and Lugano jurisdictional regimes will, in some circumstances, force a defendant simultaneously to defend two sets of claims arising out of the same facts in two different States.
