Overview

Members also deal with the full spectrum of both commercial and residential landlord & tenant issues, including 1954 Act renewals, service charge disputes, consents, assignments, breaches of covenant, forfeiture, break notices, dilapidations and possession actions.

Chambers has particular specialisms in the law relating to water and waterways, rights of light and restrictive covenants.

A particular strength of chambers is the ability of members of chambers to deal not simply with real property and landlord and tenant matters, but also with complementary areas of practice. Members are experienced in dealing with cases that present issues in company law, insolvency (such as CVAs), and civil fraud and trusts issues including beneficial ownership.

Described recently by Chambers & Partners as "superlative and top of the tree" and as a "renowned trial advocate", Liz Jones QC has a broad Chancery/Commercial practice. She also sits as a deputy Judge in the Chancery Division and regularly mediates disputes across the Chancery/ Commercial field.



Andrew Francis

Andrew is recognised by many as the "go to" barrister in restrictive covenants and rights of light matters. His work also spans other areas of real property law, such as boundaries, registered land matters, party walls, overage and easements generally. His considerable experience is projected into his books on covenants, rights of light and private rights of way. During the past year he has appeared as counsel in 4 final hearings in the Upper Tribunal (Lands Chamber) to modify covenants. It is that which has prompted his subject for this seminar.



Andrew Bruce

Andrew is a successful and well-regarded property barrister, whose measured advocacy compliments his intellectually rigorous paperwork. Andrew Gurr

Andrew joined Chambers in October 2021 following the successful completion of pupillage. He was supervised by Gareth Tilley, Dan McCourt Fritz, James Brightwell, Matthew Morrison and Christopher Stoner QC. He has recently completed a secondment with the commercial litigation team at Peters & Peters building his experience of complex international fraud and asset tracing claims. Andrew is interested in the whole range of Chancery and Commercial work and has particular interests in civil fraud, property, commercial remedies, and trusts (including specialist trust issues in matrimonial finance).

Before joining Serle Court, Andrew studied law at Clare College, Cambridge. He graduated with a double first-class undergraduate degree, the top mark on the Cambridge LLM and several university prizes and scholarships. During his BPTC year Andrew was a Queen Mother's Scholar at Middle Temple and taught Land Law to undergraduate students at Wolfson College, Cambridge.
