Recent Cases

- *Friend v Friend Media Technology Systems Ltd* [2026] EWHC 1056 (KB) – In which the High Court approved the rationale given in *Matrix Receivables Limited v Musst Holdings Limited* [2024] EWHC 2167 (Ch) as to the usual costs order following an unsuccessful application for strike out or summary judgment. A substantial award of costs was made in favour of John's client (led by **Matthew Morrison KC**).
